

## James C. Miller III Appointed to Clean Energy Board of Directors

# Veteran Government, Private Sector and Academic Leader Currently Chairs U.S. Postal Service Board of Governors

Seal Beach, CA (June 19, 2006) - Clean Energy has named James C. Miller III, former Director of the U.S. Office of Management and Budget, as a member of the company's board of directors.

Currently serving as Chairman of the Board of Governors of the United States Postal Service (USPS), Mr. Miller previously was Chairman of the CapAnalysis Group, an economic, financial and regulatory consulting firm associated with the international law firm Howrey, LLP. As the former Director of the U.S. Office of Management and Budget, Mr. Miller was a member of the President's Cabinet and a member of the National Security Council (1985-1988.) From 1981 to 1985, he chaired the U.S. Federal Trade Commission.

Mr. Miller has also authored more than 100 articles in professional journals and has authored, co-authored or edited nine books.
